It relies on internal interrelationships among different prognostic factors and the specified outcome to fill in missing observations so that an individually tailored probabilistic prediction is possible, even with incomplete patient data. PCM is applied to 1,222 melanoma patients from the United States and to 1,225 patients from Finland with invasive breast cancer. Substantial improvements in prognostic accuracy are realized in both applications compared to current prognostic practice. Greater accuracy can lead to better treatment selection decisions and to other improvements in patient management. Greater prognostic accuracy can also eliminate unnecessary medical procedures that are frequently both painful and expensive in treating progressive diseases such as cancer.
