CPT Code 97113: Aquatic Therapy

THE 15-MINUTE UNIT TIME MUST BE CAREFULLY TRACKED TO ENSURE ACCURATE BILLING, AS THE CODE IS TIME-BASED.

Distinguishing Aquatic Therapy from Other Therapy Codes

IT IS IMPORTANT TO DIFFERENTIATE 97113 FROM OTHER RELATED CPT CODES SUCH AS 97110 (THERAPEUTIC EXERCISES ON LAND) OR 97112 (NEUROMUSCULAR RE-EDUCATION). AQUATIC THERAPY UNIQUELY INVOLVES WATER-BASED THERAPEUTIC PROCEDURES, WHICH REQUIRE SEPARATE DOCUMENTATION AND CODING. PROPER USAGE OF 97113 PREVENTS CONFUSION AND ENSURES CORRECT REIMBURSEMENT.

CPT CODE 97113 IS REPORTED IN 15-MINUTE INCREMENTS. PROVIDERS SHOULD DOCUMENT THE EXACT TIME SPENT PERFORMING AQUATIC THERAPY EXERCISES, EXCLUDING PREPARATION OR REST PERIODS. FOR EXAMPLE, IF A PATIENT RECEIVES 30 MINUTES OF AQUATIC THERAPY, THE PROVIDER SHOULD BILL FOR TWO UNITS OF 97113.

NECESSARY DOCUMENTATION

TO SUPPORT BILLING, DOCUMENTATION MUST INCLUDE:

- PATIENT'S DIAGNOSIS AND MEDICAL NECESSITY FOR AQUATIC THERAPY
- DESCRIPTION OF THERAPEUTIC EXERCISES PERFORMED IN THE AQUATIC ENVIRONMENT
- DURATION OF EACH THERAPY SESSION
- PATIENT'S RESPONSE AND PROGRESS TOWARDS THERAPY GOALS

PROPER DOCUMENTATION NOT ONLY VALIDATES THE USE OF THE CPT CODE BUT ALSO ENHANCES THE QUALITY OF PATIENT CARE RECORDS.

INSURANCE COVERAGE AND REIMBURSEMENT

UNDERSTANDING INSURANCE COVERAGE POLICIES FOR AQUATIC THERAPY IS CRUCIAL FOR MAXIMIZING REIMBURSEMENT AND MINIMIZING CLAIM DENIALS. COVERAGE VARIES BY INSURER AND PLAN, BUT MANY RECOGNIZE THE THERAPEUTIC VALUE OF AQUATIC THERAPY WHEN APPROPRIATELY DOCUMENTED.

PRIVATE INSURANCE CONSIDERATIONS

PRIVATE INSURERS OFTEN REQUIRE PRIOR AUTHORIZATION FOR AQUATIC THERAPY. THEY ALSO EXPECT DOCUMENTATION DEMONSTRATING THAT AQUATIC THERAPY IS INTEGRAL TO THE PATIENT'S TREATMENT PLAN. SOME POLICIES MAY LIMIT THE NUMBER OF COVERED SESSIONS OR REQUIRE CO-PAYS.

TIPS FOR SUCCESSFUL REIMBURSEMENT

1. CONFIRM PATIENT INSURANCE BENEFITS PRIOR TO TREATMENT
2. USE CPT CODE 97113 ACCURATELY AND IN ACCORDANCE WITH TIME SPENT
3. MAINTAIN THOROUGH AND PRECISE DOCUMENTATION SUPPORTING MEDICAL NECESSITY

4. SUBMIT CLAIMS PROMPTLY AND FOLLOW UP ON DENIALS OR REQUESTS FOR ADDITIONAL INFORMATION
