#### BILLING CONSIDERATIONS

When billing for a CPT well woman exam, it is important to distinguish between new and established patients, as this affects the choice of code. Additionally, if problem-oriented services are provided during the visit, separate coding may be necessary. Documentation must support the preventive nature of the services rendered.
