THEY SOUGHT AN INJUNCTION TO COMPEL THE BOARD TO REINSTATE HIGH SCHOOL CLASSES OR PROVIDE EQUIVALENT ALTERNATIVES.

DEFENSE'S POSITION

THE DEFENSE ARGUED THAT THE BOARD OF EDUCATION ACTED WITHIN ITS AUTHORITY TO ALLOCATE RESOURCES AS IT SAW FIT. THEY CITED BUDGET LIMITATIONS AND CLAIMED THAT MAINTAINING SEPARATE SCHOOLS REQUIRED DIFFICULT FINANCIAL DECISIONS. THE DEFENSE ALSO RELIED ON PRECEDENTS THAT ALLOWED FOR SEGREGATION UNDER THE "SEPARATE BUT EQUAL" DOCTRINE, ASSERTING THAT NO CONSTITUTIONAL VIOLATION OCCURRED IF FACILITIES WERE PROVIDED, ALBEIT SEPARATELY.

JUDICIAL OUTCOMES

THE COURTS ULTIMATELY SIDED WITH THE BOARD OF EDUCATION, UPHOLDING THE CLOSURE OF THE BLACK HIGH SCHOOL. THE RULING EMPHASIZED THE BOARD'S DISCRETION IN MANAGING SCHOOL FINANCES AND DID NOT FIND SUFFICIENT GROUNDS TO DECLARE THE ACTION UNCONSTITUTIONAL. THIS DECISION REFLECTED THE PREVAILING JUDICIAL ATTITUDES OF THE TIME, WHICH OFTEN DEFERRED TO LOCAL AUTHORITIES IN MATTERS OF RACIAL SEGREGATION AND EDUCATIONAL POLICY. HOWEVER, THE CASE LAID THE GROUNDWORK FOR FUTURE LEGAL CHALLENGES TO SEGREGATION IN EDUCATION.

IMPACT OF THE CUMMING VS BOARD OF EDUCATION DECISION
