LEGAL FOUNDATIONS OF FREEDOM OF SPEECH

SCOPE AND LIMITS OF FREE SPEECH

APPLICATION TO DIGITAL COMMUNICATION

- IMPERSONATION OR IDENTITY THEFT TO HARM REPUTATION
- EXCLUSION OR PUBLIC SHAMING IN DIGITAL COMMUNITIES
- POSTING HUMILIATING IMAGES OR VIDEOS WITHOUT CONSENT

DISTINCTIONS BETWEEN CYBERBULLYING AND PROTECTED SPEECH

WHILE CYBERBULLYING INVOLVES HARMFUL BEHAVIOR, IT MUST BE DIFFERENTIATED FROM LEGITIMATE FREE SPEECH. EXPRESSIONS OF OPINION, SATIRE, OR CRITICISM TYPICALLY FALL UNDER PROTECTED SPEECH, WHEREAS TARGETED HARASSMENT OR THREATS DO NOT. THE CHALLENGE LIES IN IDENTIFYING WHEN ONLINE CONDUCT CONSTITUTES PUNISHABLE CYBERBULLYING RATHER THAN CONSTITUTIONALLY PROTECTED EXPRESSION.

INTERSECTION OF CYBERBULLYING AND FREEDOM OF SPEECH
