IMPORTANCE OF CONTINUING EDUCATION FOR PEST CONTROL PROFESSIONALS IN CALIFORNIA

THE REQUIRED CREDIT HOURS VARY DEPENDING ON THE LICENSE CATEGORY, SUCH AS QUALIFIED APPLICATOR LICENSE (QAL) OR QUALIFIED APPLICATOR CERTIFICATE (QAC).

APPROVED COURSE CONTENT AND PROVIDERS

CONTINUING EDUCATION COURSES MUST BE APPROVED BY THE CALIFORNIA DPR TO QUALIFY FOR CREDIT. TOPICS TYPICALLY INCLUDE PESTICIDE LAWS, SAFETY PROTOCOLS, ENVIRONMENTAL PROTECTION, AND INTEGRATED PEST MANAGEMENT.
