Overview of I-130 and I-485 Petitions

Outcomes of the I-130 Interview

Successful completion of the I-130 interview generally leads to USCIS approval of the petition, allowing the beneficiary to proceed with visa processing or adjustment of status. If concerns arise, USCIS may issue a Request for Evidence (RFE) or notice of intent to deny (NOID).

Outcomes of the I-485 Interview

An approved I-485 interview results in the applicant receiving lawful permanent resident status. If issues are identified, USCIS may issue an RFE, schedule a second interview, or deny the application. In some cases, an interview waiver may be granted based on specific eligibility criteria.

The I-130 interview primarily focuses on verifying the legitimacy of the family relationship petitioned for, while the I-485 interview focuses on the applicant's eligibility for adjustment of status to permanent residency.
