DEFINITION AND PURPOSE

THE TERM "IMPEACHMENT" REFERS SPECIFICALLY TO THE ACT OF ACCUSING AN OFFICIAL OF WRONGDOING. ITS MAIN PURPOSE IS TO PROTECT THE INTEGRITY OF THE GOVERNMENT AND PRESERVE THE RULE OF LAW BY ADDRESSING ABUSES OF POWER. IMPEACHMENT SERVES AS A CONSTITUTIONAL SAFEGUARD AGAINST TYRANNY AND CORRUPTION.

ANDREW JOHNSON'S IMPEACHMENT (1868)

ANDREW JOHNSON WAS THE FIRST U.S. PRESIDENT TO BE IMPEACHED. HIS IMPEACHMENT CENTERED ON HIS VIOLATION OF THE TENURE OF OFFICE ACT BY REMOVING SECRETARY OF WAR EDWIN STANTON. THE HOUSE IMPEACHED JOHNSON, BUT THE SENATE FELL ONE VOTE SHORT OF THE TWO-THIRDS MAJORITY NEEDED FOR CONVICTION, ALLOWING HIM TO REMAIN IN OFFICE.

BILL CLINTON'S IMPEACHMENT (1998)

BILL CLINTON FACED IMPEACHMENT ON CHARGES OF PERJURY AND OBSTRUCTION OF JUSTICE RELATED TO HIS EXTRAMARITAL AFFAIR WITH MONICA LEWINSKY. THE HOUSE APPROVED TWO ARTICLES OF IMPEACHMENT, BUT THE SENATE ACQUITTED HIM, HIGHLIGHTING THE POLITICAL COMPLEXITY OF SUCH PROCEEDINGS.

DONALD TRUMP'S IMPEACHMENTS (2019 AND 2021)

DONALD TRUMP IS THE ONLY U.S. PRESIDENT TO BE IMPEACHED TWICE. THE FIRST IMPEACHMENT INVOLVED CHARGES OF ABUSE OF POWER AND OBSTRUCTION OF CONGRESS RELATED TO UKRAINE. THE SECOND IMPEACHMENT CHARGED HIM WITH INCITEMENT OF INSURRECTION FOLLOWING THE JANUARY 6 CAPITOL ATTACK. BOTH TRIALS ENDED IN ACQUITTAL BY THE SENATE.

CONSTITUTIONAL FOUNDATIONS AND LEGAL FRAMEWORK

THE UNITED STATES CONSTITUTION PROVIDES THE LEGAL BASIS FOR IMPEACHMENT, OUTLINING THE GROUNDS, PROCEDURES, AND ROLES OF CONGRESS. UNDERSTANDING THIS FRAMEWORK IS ESSENTIAL TO ANSWERING WORKSHEET QUESTIONS ACCURATELY.

ARTICLE I: POWERS OF CONGRESS

THE PHRASE "HIGH CRIMES AND MISDEMEANORS" HAS BEEN SUBJECT TO INTERPRETATION, OFTEN ENCOMPASSING SERIOUS ABUSES OF POWER OR BREACHES OF PUBLIC TRUST.

ROLE OF THE JUDICIARY

THE CHIEF JUSTICE OF THE UNITED STATES PRESIDES OVER PRESIDENTIAL IMPEACHMENT TRIALS IN THE SENATE, ENSURING PROCEDURAL FAIRNESS AND ADHERENCE TO CONSTITUTIONAL REQUIREMENTS.

PROCEDURES AND POLITICAL IMPLICATIONS OF IMPEACHMENT

POLITICAL CONSIDERATIONS

IMPEACHMENT IS INHERENTLY POLITICAL, AS DECISIONS OFTEN REFLECT PARTY INTERESTS, PUBLIC OPINION, AND BROADER POLITICAL DYNAMICS. IT MAY REINFORCE ACCOUNTABILITY OR DEEPEN PARTISAN DIVISIONS DEPENDING ON THE CONTEXT.

CONSEQUENCES OF IMPEACHMENT

BEYOND REMOVAL, IMPEACHMENT CAN DAMAGE POLITICAL CAREERS, INFLUENCE PUBLIC TRUST, AND SET PRECEDENTS FOR FUTURE CONDUCT OF OFFICIALS. IT ALSO UNDERSCORES THE IMPORTANCE OF CONSTITUTIONAL LIMITS ON EXECUTIVE POWER.
