REASONS FOR IMMIGRATION RELIEF

QUESTIONS IN THIS CATEGORY FOCUS ON WHY THE INDIVIDUAL IS SEEKING IMMIGRATION RELIEF. THIS MAY INCLUDE INQUIRIES ABOUT:

- FEAR OF PERSECUTION OR HARM IN THEIR HOME COUNTRY

- CONNECTIONS TO THE UNITED STATES, SUCH AS FAMILY OR EMPLOYMENT

CREDIBILITY AND CONSISTENCY CHECKS

IT IS ADVISABLE TO ANSWER QUESTIONS DIRECTLY WITHOUT VOLUNTEERING UNNECESSARY INFORMATION. STAYING FOCUSED HELPS AVOID MISUNDERSTANDINGS AND LIMITS OPPORTUNITIES FOR ADVERSE INTERPRETATIONS.

STAY CALM AND RESPECTFUL

MAINTAINING A RESPECTFUL DEemeanOR TOWARD THE JUDGE AND ATTORNEYS HELPS CREATE A POSITIVE IMPRESSION. REMAINING CALM UNDER QUESTIONING DEMONSTRATES COMPOSURE AND RELIABILITY.

SEEK LEGAL ASSISTANCE
