CORE CONCEPTS OF IMMUNITY TO CHANGE

IN THIS STEP, PARTICIPANTS IDENTIFY THE HIDDEN COMMITMENTS THAT DRIVE THE COUNTERPRODUCTIVE BEHAVIORS. THESE COMPETING COMMITMENTS REPRESENT FEARS OR CONCERNS THAT PROTECT THE INDIVIDUAL FROM PERCEIVED RISKS ASSOCIATED WITH CHANGE.

STEP 4: UNCOVERING BIG ASSUMPTIONS

THE FINAL STEP INVOLVES SURFACING THE UNDERLYING ASSUMPTIONS OR BELIEFS THAT SUPPORT THE COMPETING COMMITMENTS. THESE ASSUMPTIONS ARE OFTEN DEEP-ROOTED AND REQUIRE CRITICAL EXAMINATION TO CHALLENGE AND REVISE.
