INSURANCE COVERAGE AND POLICY OPTIONS

THE MEDICAL MUTUAL LIABILITY INSURANCE SOCIETY OF MARYLAND OFFERS A VARIETY OF INSURANCE PRODUCTS TAILORED SPECIFICALLY TO THE MEDICAL COMMUNITY. PROFESSIONAL LIABILITY INSURANCE

AT THE CORE OF THE SOCIETY'S OFFERINGS IS PROFESSIONAL LIABILITY INSURANCE, COMMONLY KNOWN AS MEDICAL MALPRACTICE INSURANCE. THIS COVERAGE PROTECTS MEDICAL PROFESSIONALS AGAINST CLAIMS ARISING FROM ALLEGED ERRORS, OMISSIONS, OR NEGLIGENCE IN THE DELIVERY OF HEALTHCARE SERVICES. COVERAGE TYPICALLY INCLUDES LEGAL DEFENSE COSTS, SETTLEMENTS, AND JUDGMENTS UP TO THE POLICY LIMITS.

GENERAL LIABILITY AND OTHER SUPPLEMENTAL COVERAGES

IN ADDITION TO PROFESSIONAL LIABILITY, THE SOCIETY MAY PROVIDE OR FACILITATE ACCESS TO GENERAL LIABILITY INSURANCE, WHICH COVERS CLAIMS RELATED TO BODILY INJURY OR PROPERTY DAMAGE OCCURRING ON THE INSURED'S PREMISES. SOME POLICIES ALSO OFFER SUPPLEMENTAL COVERAGES SUCH AS CYBER LIABILITY, EMPLOYMENT PRACTICES LIABILITY, AND REGULATORY COMPLIANCE ASSISTANCE TO ADDRESS EMERGING RISKS IN HEALTHCARE.

CUSTOMIZED POLICY STRUCTURES
