STEPS INVOLVED IN MEDICATION RECONCILIATION

STEP 5: DOCUMENTING AND COMMUNICATING

FINALLY, THE UPDATED AND ACCURATE MEDICATION LIST IS DOCUMENTED IN THE MEDICAL RECORD AND COMMUNICATED TO ALL RELEVANT MEMBERS OF THE HEALTHCARE TEAM TO ENSURE CONTINUITY OF CARE.
