THEY MUST FOLLOW STRICT PROTOCOLS TO ENSURE PATIENT SAFETY AND REPORT ANY ADVERSE REACTIONS OR CONCERNS TO SUPERVISING NURSES PROMPTLY. UNDERSTANDING THE SCOPE OF PRACTICE IS ESSENTIAL FOR MEDICATION AIDES TO OPERATE WITHIN LEGAL AND PROFESSIONAL BOUNDARIES.

ELIGIBILITY AND PREREQUISITES FOR TRAINING

APPLICATION PROCESS

- SUBMIT A COMPLETED APPLICATION ALONG WITH REQUIRED FEES

THE COMPETENCY EVALUATION TYPICALLY INCLUDES A WRITTEN EXAM AND A PRACTICAL SKILLS TEST FOCUSED ON MEDICATION ADMINISTRATION.

RENEWAL AND CONTINUING EDUCATION

CERTIFICATION MUST BE RENEWED PERIODICALLY, AS REQUIRED BY TENNESSEE STATE REGULATIONS. MEDICATION AIDES ARE ENCOURAGED TO PARTICIPATE IN CONTINUING EDUCATION TO STAY UPDATED WITH CURRENT PRACTICES, LAWS, AND SAFETY PROTOCOLS. WHAT TOPICS ARE COVERED IN TENNESSEE MEDICATION AIDE TRAINING?

THE TRAINING COVERS MEDICATION ADMINISTRATION PRINCIPLES, ANATOMY AND PHYSIOLOGY BASICS, MEDICATION SAFETY,

RECORD KEEPING, COMMUNICATION SKILLS, LEGAL AND ETHICAL RESPONSIBILITIES, AND HANDS-ON PRACTICE WITH MEDICATION ADMINISTRATION UNDER SUPERVISION.

IS CERTIFICATION REQUIRED TO WORK AS A MEDICATION AIDE IN TENNESSEE?

YES, CERTIFICATION IS REQUIRED. AFTER COMPLETING THE APPROVED MEDICATION AIDE TRAINING PROGRAM, CANDIDATES MUST PASS A COMPETENCY EXAM TO BECOME A CERTIFIED MEDICATION AIDE (CMA) AUTHORIZED TO ADMINISTER MEDICATIONS IN TENNESSEE HEALTHCARE FACILITIES.

WHERE CAN I FIND APPROVED MEDICATION AIDE TRAINING PROGRAMS IN TENNESSEE?

APPROVED TRAINING PROGRAMS ARE OFFERED BY COMMUNITY COLLEGES, VOCATIONAL SCHOOLS, AND SOME HEALTHCARE FACILITIES ACROSS TENNESSEE. THE TENNESSEE DEPARTMENT OF HEALTH WEBSITE PROVIDES A LIST OF STATE-APPROVED MEDICATION AIDE TRAINING PROGRAMS.

WHAT TYPES OF MEDICATIONS ARE MEDICATION AIDES ALLOWED TO ADMINISTER IN TENNESSEE?

IN TENNESSEE, MEDICATION AIDES ARE ALLOWED TO ADMINISTER ORAL, TOPICAL, AND SOME INHALED MEDICATIONS UNDER THE SUPERVISION OF A LICENSED NURSE, BUT THEY ARE GENERALLY NOT PERMITTED TO ADMINISTER INJECTIONS OR INTRAVENOUS MEDICATIONS.
