PURPOSE AND IMPORTANCE OF FINANCIAL AID

THIS SUPPORT NOT ONLY ENCOURAGES ENROLLMENT BUT ALSO PROMOTES STUDENT RETENTION AND COMPLETION RATES. FINANCIAL AID PROGRAMS ARE CRITICAL IN BRIDGING THE GAP BETWEEN EDUCATIONAL ASPIRATIONS AND FINANCIAL CAPABILITIES.

FINANCIAL AID OFFICE AND SUPPORT SERVICES

TYPES OF FINANCIAL AID AVAILABLE

GRANTS

GRANTS ARE FUNDS AWARDED BASED ON FINANCIAL NEED AND DO NOT REQUIRE REPAYMENT. POLK STATE PARTICIPATES IN FEDERAL AND STATE GRANT PROGRAMS SUCH AS THE PELL GRANT AND THE FLORIDA STUDENT ASSISTANCE GRANT (FSAG). THESE GRANTS PROVIDE SUBSTANTIAL SUPPORT TO ELIGIBLE STUDENTS TO COVER TUITION AND RELATED COSTS.

SCHOLARSHIPS

SCHOLARSHIPS AT POLK STATE ARE MERIT-BASED OR NEED-BASED AWARDS THAT RECOGNIZE ACADEMIC ACHIEVEMENT, LEADERSHIP, COMMUNITY INVOLVEMENT, OR SPECIFIC TALENTS. INSTITUTIONAL SCHOLARSHIPS ARE OFFERED BY POLK STATE COLLEGE, AND STUDENTS CAN ALSO EXPLORE EXTERNAL SCHOLARSHIP OPPORTUNITIES TO SUPPLEMENT THEIR FINANCIAL AID PACKAGE.

LOANS

STUDENT LOANS ARE BORROWED FUNDS THAT MUST BE REPAYED WITH INTEREST AFTER GRADUATION OR WHEN THE STUDENT CEASES ENROLLMENT. POLK STATE FACILITATES FEDERAL STUDENT LOAN PROGRAMS SUCH AS DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS. THESE LOANS PROVIDE FLEXIBLE REPAYMENT PLANS AND LOWER INTEREST RATES COMPARED TO PRIVATE LOANS.

WORK-STUDY PROGRAMS

THE FEDERAL WORK-STUDY PROGRAM AT POLK STATE PROVIDES PART-TIME EMPLOYMENT OPPORTUNITIES FOR ELIGIBLE STUDENTS. THIS PROGRAM ALLOWS STUDENTS TO EARN MONEY TO HELP PAY EDUCATIONAL EXPENSES WHILE GAINING VALUABLE WORK EXPERIENCE. POSITIONS MAY BE ON-CAMPUS OR WITH APPROVED COMMUNITY ORGANIZATIONS.

ELIGIBILITY REQUIREMENTS FOR FINANCIAL AID

ELIGIBILITY FOR POLK STATE FINANCIAL AID DEPENDS ON SEVERAL FACTORS, INCLUDING CITIZENSHIP STATUS, ENROLLMENT STATUS, ACADEMIC PROGRESS, AND FINANCIAL NEED. CITIZENSHIP AND RESIDENCY

DOCUMENTATION VERIFYING CITIZENSHIP OR RESIDENCY STATUS IS TYPICALLY REQUIRED DURING THE APPLICATION PROCESS.

ENROLLMENT STATUS

STUDENTS MUST BE ENROLLED AT LEAST HALF-TIME IN AN ELIGIBLE DEGREE OR CERTIFICATE PROGRAM TO RECEIVE POLK STATE

FINANCIAL AID. ENROLLMENT STATUS CAN AFFECT THE AMOUNT OF AID AWARDED. FULL-TIME STUDENTS MAY QUALIFY FOR HIGHER AID AMOUNTS COMPARED TO PART-TIME STUDENTS.

SATISFACTORY ACADEMIC PROGRESS (SAP)

MAINTAINING SATISFACTORY ACADEMIC PROGRESS IS A MANDATORY REQUIREMENT FOR CONTINUED FINANCIAL AID ELIGIBILITY. POLK STATE MONITORS STUDENTS' GPA, COURSE COMPLETION RATE, AND MAXIMUM TIME FRAME FOR PROGRAM COMPLETION. FAILURE TO MEET SAP STANDARDS MAY RESULT IN SUSPENSION OR LOSS OF FINANCIAL AID.

APPLICATION PROCESS FOR POLK STATE FINANCIAL AID

APPLYING FOR POLK STATE FINANCIAL AID INVOLVES SEVERAL STEPS, INCLUDING COMPLETING THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA), SUBMITTING REQUIRED DOCUMENTATION, AND MEETING INSTITUTIONAL DEADLINES. A THOROUGH UNDERSTANDING OF THE APPLICATION PROCESS ENHANCES THE CHANCES OF RECEIVING TIMELY AND ADEQUATE AID.

COMPLETING THE FAFSA

THE FAFSA IS THE FOUNDATIONAL APPLICATION FOR MOST FEDERAL AND STATE FINANCIAL AID PROGRAMS. STUDENTS MUST PROVIDE ACCURATE FINANCIAL AND PERSONAL INFORMATION TO DETERMINE ELIGIBILITY. POLK STATE'S SCHOOL CODE MUST BE INCLUDED ON THE FAFSA TO ENSURE THE COLLEGE RECEIVES THE INFORMATION NECESSARY TO PROCESS AID APPLICATIONS.

SUBMITTING ADDITIONAL DOCUMENTATION

AFTER FAFSA SUBMISSION, SOME STUDENTS MAY BE SELECTED FOR VERIFICATION OR REQUIRED TO PROVIDE ADDITIONAL DOCUMENTS SUCH AS TAX RETURNS, PROOF OF RESIDENCY, OR ENROLLMENT VERIFICATION. PROMPT SUBMISSION OF THESE MATERIALS IS CRUCIAL TO AVOID DELAYS IN FINANCIAL AID DISBURSEMENT.

AWARD NOTIFICATION AND ACCEPTANCE

FINANCIAL LITERACY AND BUDGETING

EXTERNAL SCHOLARSHIPS AND GRANTS
