DEFICITS IN THIS AREA CAN LEAD TO MISUNDERSTANDINGS, SOCIAL ISOLATION, AND CHALLENGES IN BOTH PERSONAL AND PROFESSIONAL SETTINGS. EARLY IDENTIFICATION AND INTERVENTION FOR PRAGMATIC LANGUAGE DIFFICULTIES ARE CRUCIAL FOR IMPROVING OVERALL COMMUNICATION OUTCOMES.

# COMPONENTS OF THE PRAGMATIC LANGUAGE SKILLS INVENTORY
