## FUNCTIONS OF A PREVENTIVE SERVICES BUSINESS OFFICE

THE PREVENTIVE SERVICES BUSINESS OFFICE SERVES AS THE ADMINISTRATIVE AND FINANCIAL HUB FOR MANAGING PREVENTIVE HEALTHCARE SERVICES.
