PHARMACIES LOCATED WITHIN OR NEAR PRIMARY CARE FACILITIES PROVIDE AN ACCESSIBLE POINT OF CONTACT FOR PATIENTS

SEEKING MEDICATION ADVICE, VACCINATION, AND HEALTH SCREENING SERVICES. OUTREACH PROGRAMS CONDUCTED BY

PHARMACISTS HELP RAISE AWARENESS ABOUT MEDICATION ADHERENCE, LIFESTYLE MODIFICATIONS, AND IMMUNIZATION, THEREBY

PROMOTING HEALTHIER COMMUNITIES.

#### KEY ROLES AND RESPONSIBILITIES OF PRIMARY HEALTH CARE PHARMACISTS

PHARMACISTS IN PRIMARY HEALTH CARE SETTINGS UNDERTAKE A WIDE RANGE OF RESPONSIBILITIES THAT EXTEND BEYOND TRADITIONAL DISPENSING ROLES.
