FOUNDATIONS OF INTERNAL MEDICINE

MASTERY OF ANATOMY AND PHYSIOLOGY ALLOWS INTERNISTS TO RECOGNIZE DEVIATIONS FROM NORMAL THAT SIGNIFY DISEASE. FURTHERMORE, INTERNAL MEDICINE RELIES HEAVILY ON THE INTEGRATION OF BIOMEDICAL SCIENCES WITH CLINICAL PRACTICE TO FORM A COHERENT APPROACH TO PATIENT CARE.

PATHOPHYSIOLOGY AND DISEASE MECHANISMS
