## SEPARATION OF POWERS

- CONGRESS APPROVES PRESIDENTIAL APPOINTMENTS AND CAN IMPEACH OFFICIALS.
- THE PRESIDENT NOMINATES JUDGES, BUT THE SENATE CONFIRMS THEM.
- THE JUDICIARY CAN INVALIDATE ACTIONS BY THE LEGISLATIVE OR EXECUTIVE BRANCHES THAT VIOLATE THE CONSTITUTION.

THESE CHECKS MAINTAIN EQUILIBRIUM WITHIN THE GOVERNMENT AND ENCOURAGE COOPERATION AMONG BRANCHES.

# FEDERALISM

## DEFINITION AND STRUCTURE

FEDERALISM REFERS TO THE DIVISION OF POWER BETWEEN THE NATIONAL GOVERNMENT AND THE STATE GOVERNMENTS.
