COLLABORATION AND PEER SUPPORT

COLLABORATIVE APPROACHES ENGAGE FAMILIES, CAREGIVERS, AND COMMUNITY RESOURCES TO CREATE A SUPPORTIVE NETWORK. PEER SUPPORT CAN ALSO PLAY A VITAL ROLE IN HEALING AND RECOVERY.

CULTURAL, HISTORICAL, AND GENDER AWARENESS

Trauma-informed practice respects and integrates cultural, historical, and gender contexts. This awareness helps avoid biases and ensures interventions are relevant and sensitive to individual backgrounds.
